#### **Country Aspects**

#### 1. PHYSICAL ASPECTS

#### 1.1.WATER RESOURCES

#### 1.1.1.WATER RESOURCES

The drainage basins of Cameroon are:

- •the Logone and its tributaries, which drain the extreme north to Lake Chad, covering 11 per cent of the country;
- •the Benue and its tributaries (the Faro, the Mandara, the Alantika Kebi and the Mayo), which drain the north to the Niger river and occupy 19 per cent of the country;
- •the Ngoko and Kadei rivers, which drain south-east towards the Sangha, a tributary of the Congo, which cover 20 per cent of the country;
- •the main rivers of the centre and west, which flow into the Atlantic: the Sanaga, the longest river in the country (920km) whose basin covers 140,000km2 (30 per cent of the national territory), and the Nyong, Ntem, Mungo and Wouri, which cover 20 per cent.

Cameroon has significant groundwater resources, which are divided between the major aquifers and include:

- •the base area of 430,000km2 (90 per cent of the country), which contains about 79km3;
- •the coastal basin of 7,500km2, which contains a volume of recoverable reserves of over 21km3;
- •the basin of the Benue, which covers some 7,800km2 and has 15km3 of mineable reserves;
- •the Chad basin, which covers 19,800km2;
- •some small sub-basins, which cover a total of 9,900km2.

The internal renewable surface water resources are estimated at 268km3, and the internal renewable groundwater resources at 100km3. Taking into account a common part between surface water and groundwater of about 95km3, the internal renewable water resources total 273km3. Considering the rivers entering the country (such as the Benue, coming from Chad, with 4km3) or forming the border (such the Logone, between Cameroon and Chad), the total renewable water resources are estimated at 285.5km3/year.

Wetlands are represented by Yaérés (floodplains formed from river runoff or overflow) in the extreme north and northeast and the mangrove area of the coast between the estuary and the Wouri border with Nigeria. The Yaérés of the Waza-Logone region in the extreme north have been the subject of a development project funded by the European Union and implemented by the World Conservation Union (IUCN).

The Cameroon contains a large number of lakes. The most important are:

- ·Lake Chad, shared with Nigeria, Niger and Chad;
- •the volcanic lakes of Nyos (158ha), Barombi Mbo (415ha) and Oka (243ha);

•the tectonic lakes of Ossa, Dissoni and Ejagham.

The major dams and reservoirs have a total capacity of 15,326km3.

#### 1.1.2.WATER USE

The main water uses, in order of importance, are: agriculture (74 per cent), domestic uses (18 per cent) and industry (8 per cent). Total withdrawals in 2000 were 985 million m3.

#### 1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

Water-borne diseases are prevalent in Cameroon; other current environmental problems are deforestation, overgrazing, desertification, poaching and overfishing.

The water used for irrigation in urban areas is heavily polluted. Rural water quality remains good, given the low use of pesticides and fertilizers in agriculture. The risk of pollution from industrial and human groundwater from the Douala region is significant.

#### 2. GOVERNANCE ASPECTS

#### 2.1.WATER INSTITUTIONS

The water sector falls under three ministries:

- •the Ministry of Mines, Water and Energy (MINMEE), which is responsible for overseeing exploration and rational exploitation of water resources, and for the design and implementation of sanitation policy. Formerly under the MINMEE and currently undergoing privatization, the National Water Company of Cameroon (SNEC) is responsible for supplying drinking water in urban areas, while the Water Directorate of the Ministry is responsible for water procurement in urban and rural areas:
- •the Ministry of Agriculture is responsible for developing and implementing government programmes related to irrigation and drainage. Government policy is oriented towards the establishment of irrigation systems at prices within the reach of small farmers and the development of a strayegy for agricultural and pastoral water. The Ministry of Livestock, Fisheries and Animal Industry assists in the implementation of this policy;
- •the Water Research Centre (HRC) is under the Ministry of Scientific Research and responsible for technical supervision of the water cycle and water quality and the inventory and valuation of water resources.

Private structures, such as SEMRY and UNVDA, are also involved in the management of irrigation. The withdrawal of the state from the irrigation sector after the crisis of 1980-1990 resulted in decreased productivity throughout the sector. In order to boost irrigated production, the state now directs its policy towards improving the operation of existing schemes, promoting small irrigation and encouraging private sector investment in irrigation.



#### 2.2. WATER MANAGEMENT

Water resource management in Cameroon is central to poverty alleviation and to sustainable development. Significant sections of the population suffer mainly due to poor water management rather than to actual water shortages. About 42 per cent of Cameroonians do not have access to adequate drinking water; this is a striking statistic for a country endowed with abundant freshwater resources.

Water governance has been improving in Cameroon but at a very slow rate. Water is considered to be state property, so the state is responsible for the protection and management of this resource and there are many institutions involved in such management. Thus, the IWRM concept is now widely accepted as the starting point for the development of water policies that can enhance sustainable water resources management in the country.

In major rice-growing areas, two bodies are responsible for day-to-day management:

- •a branch with responsibility for maintenance of major infrastructures and for monitoring and coordinating production and marketing;
- •collective organizations of irrigators who maintain networks and manage the distribution of water.

Water management and production is privatized in banana areas.

The traditional areas are managed by the irrigators, either individually or in small groups. These can take two forms:

- •community groups where all agricultural activity is carried out by all operators and the purpose is the equal sharing of production;
- •common initiative groups in which operators work individually but share a number of services or means of production.

#### 2.3. WATER POLICY AND LEGAL FRAMEWORK

There is no specific legislation for irrigation and drainage. However, the country has a law concerning the water regime, namely Law No. 98/005 of 14 April, 1998. This law establishes the legal framework of the water regime and covers protection against water pollution, preservation of water resources, the provision of quality water for drinking and penalties due for non-compliance.

#### 3. GEOPOLITICAL ASPECTS

The use of water from the Logone, which marks the border between Cameroon and Chad, is regulated by an agreement (known as the Moundou agreement) signed in August 1970 between the two countries. This agreement sets maximum quantities of water that can be taken by both countries in the dry season. These amounts are 5m3/s from January to April and 10m3/s in May and December.

Cameroon is also included in the river basins of the Congo (Zaire), Lake Chad and the Niger river. It is a member of the Board of the Lake Chad Basin (LCBC) and the Niger Basin Authority (NBA).

The Niger Basin Authority defines its purpose as the promotion of cooperation among member

countries to ensure integrated development of resources. The organisation originally defined its mission as the cooperative management of water resources, most notably, but not limited to, the Niger river.

The NBA nations seek to harmonize the development of energy, agriculture, forestry, transport, communications and industrial resources. The NBA has worked to create an Integrated Development Plan of the Basin, focussing especially on cross- boundary projects. The NBA itself has been ceded no sovereign power over resources or management, and therefore all regulation must be imposed by individual sovereign governments. While not the original focus of the NBA, environmental protection from the threats of desertification, deforestation and pollution of the rivers by agriculture and industry have become major themes of their work.
